ANNUAL PLAN FOR PROCUREMENT FROM MICRO AND SMALL ENTERPRISES

MCL has implemented Public Procurement Policy, MSEs Order 2012 since July 2013 and continuously achieving more than 20% target of procurement from MSEs of total goods and services that can be produced or rendered by MSEs. For the FY 2018-19 the total percentage of procurement from MSEs (including MSEs owned by SC/ST entrepreneurs) out of total procurement on goods and services that can be produced and rendered by MSEs is 40.11% which is **well above 25%** mandatory target as per recent circulars. The annual action plan for the FY 2019-20 is given below:
