## NOTICE

## OFFER OF ADDITIONAL COAL ON "AS IS WHERE IS" BASIS FOR POWER GENERATING COMPANIES INCLUDING IPPS DRAWING COAL UNDER FSA

This is further to our earlier notice no.MCL/SBP/GM-S&M/2012/656, dtd.13.06.2012 & 731, dtd.19/20.06.2012 regarding offer of coal to all power generating companies including IPPs drawing coal under FSA during 2012-13 by making their own arrangement for evacuation on 'as is where is' basis, CIL vide letter no.CIL/S&M/As Is Where Is/125, dtd.28.03.2013, has conveyed the approval of continuance of "as is where is basis scheme" for the year 2013-14 as under :

## <u>Quote</u>

- I. The 'as is where is basis' scheme would be available as an additional means for stock liquidation, apart from the already available provision under the New FSA for offering coal to the new power plants from three coal companies namely SECL, MCL and CCL to the extent of 5% of ACQ and to be lifted by the power plants by road/road-cum-rail mode.
- II. The 'as is where is basis' scheme for Power Generating Companies including IPPs drawing coal under FSA from the pit-head stocks/loading points of the coal companies may be continued during the year 2013-14 including the three coal companies namely CCL, SECL and MCL where the provision for supply of 5% of the ACQ through RCR mode is already provided under the New FSA applicable to Power Plants.

In view of the above, the following collieries are put under the above scheme for 2013-14 as one time offer with the stipulation that power generating companies including IPPs drawing coal under FSA will have to make their own arrangement for evacuation.
