Notice for Change of Mode of supply from Road to Rail pertaining to order booked under Special Forward e-Auction scheme

As per directive received from CIL, temporary dispensation for change of mode from Road to Rail pertaining to the order booked under Special Forward e-Auction scheme has been extended to all willing consumer/bidders subject to following conditions:

- The temporary dispensation shall be allowed for the period of exigency initially for three months i.e. April to June'2020 and after review with CIL for another three months, if required.
- Transportation of coal from stock to siding(s) is being arranged by the concerned Area of MCL.
- There shall not be any adjustment of grade/quantity for availing supply under such dispensation. An undertaking shall be submitted by the willing consumer to MCL in this regard.
- It shall be ensured that such dispensation will not entail any adverse financial implication.
- The modality of calculation of premium payable by the Bidders for the change of mode from Road to Rail in terms of the said dispensation shall be as below:
 - In case of change of mode of transport from Road to Rail in case of Special Forward e-Auction(SFEA), the % premium chargable shall be higher of the following:
 - (i) % premium at which the Bidder had secured the quantities by Road mode from the original source.
 - (ii) highest % premium over the notified price under SFEA from the temporary Rail mode source during the last 2 years i.e 2018-19 and 2019-20.

In case no coal has been booked from the railway siding under the SFEA scheme during the last two year i.e. 2018-19 and 2019-20, the % premium of original road source of the bidder shall be applicable for supply of coal from temporay source i.e Rail siding.

- This dispensation shall be optional in nature.
- Fresh bookings from Apr'20-June'20 under Special forward e-Auction shall be eligible for such dispensation.
- The valid RDOs whose validity/Extended validity is falling between April'20 to June'2020 shall also be eligible for such change of mode of delivery. Consumer may so opt for partial lifted RDOs also.

Willing consumers are advised to submit their consent with a request to avail such dispensation.
