All the non-power Consumers having valid FSA with MCL and the buyers under special Forward/ Exclusive e-Auction are informed that as subject matter has been reviewed in GM(M&S) Co-Ordination meeting held on 16.02.2019 and further direction vide aforesaid letter has been issued, and it has been decided that facility of non payment of coal value for all consumers whose value paid pending orders are more than MSQ being extended from the month of June-19

How ever, consumers shall have to deposit fresh advance to coal company before loading of rake in such a way that the balance advance available with MCL will always remain equivalent to not less than one month coal value/MSQ.

In case of failure to maintain one month coal value at any point of time as per terms of policy, the facility will be withdrawn for defaulting consumer & MCL may cancel all pending allotments released without payment and may encash FC-BG. Any delay in payment as per terms of policy will attract interest thereof.

All the cancelled allotment if any, as above will be treated under deemed delivery and will attract compensation.

The consumers willing to avail facility shall have to submit an undertaking in the Form as in Annexure-i.
