## नोटिस

Sub: Extension of third party sampling facility for all categories of consumers drawing coal from MCL.

The approved board decision as communicated by Director Marketing, CIL regarding extension of 3<sup>rd</sup> party sampling facility for all categories of consumers drawing coal is reproduced below for kind information:

The third party sampling facility is now extended to -

- (A) Spot, Special Spot and Exclusive e-Auction schemes.
- (B) FSA consumers in Non-Power sector including state nominated agencies, for dispatch against the Monthly Scheduled Quantity (MSQ)

The above decision shall be applicable in respect of all dispatch w.e.f 11.01.2018, even against the coal secured in the events of auctions held before 01.01.2018 / booking of coal against the MSQ for the months upto Dec'2017 under FSA.

The facility is extended on optional basis for the willing consumers/bidders who are prepared to share the expenses and complete the requisite formalities. However, despatches to such consumers / bidders will be continued on declared grade basis from 11.01.2018, only after getting an undertaking to the effect that they are not willing to avail the option for third party sampling.

All categories of consumers drawing coal from MCL may opt for the above extended facility by co-coordinating with Quality Control Department, MCL Hq and third party sampling agencies for commencing the sampling on conclusion of tripartite agreement.
