NOTICE

In view of persisting local/regional lockdown and restriction in movement of vehicles in different parts of country arising out of resurgence of Covid-19, CIL vide letter no. CIL/M&S/E-Auction/273 dated 10/07/2021 has communicated approval of competent authority for extension of timeline for lifting of coal which is as under:

- In cases where the last date of lifting period of value paid orders is falling, originally or upon extension, anytime between 10.07.2021 to 19.07.2021, the lifting validity period be extended till 20.07.2021.
- The above dispensation shall be applicable for all e-auction schemes/FSA/MOU.

Accordingly, the validity of all RDO/SOs of all schemes where the last date of lifting period of value paid Sales orders is falling, originally or upon earlier extension, anytime between 10th July 2021 to 19th July 2021, the lifting validity period is extended till 20.07.2021.

The RDO/SO wise new extended validity list is enclosed as Annx-I. However all other parameter mentioned in respective RDO/SO shall remain unchanged.

Consumers/Traders are requested to lift the coal against their RDO/SO within the extended validity period.
