GM(S&M), CIL vide letter no. CIL:S&M:New Pol:47252/442, dtd.11.04.2016 has conveyed approval of 149th meeting of CIL FDs held on 31.03.2016 that supply of coal for FSA holders in non regulated sector which were extended to March 2016 may be continued to 30th June 2016 or commencement of the linkage auction, whichever is earlier.

This renewal for a period of 3(three) months, i.e., upto June'2016 shall be effective from the expiry date of current FSA.

The following are for information of all concerned :-

- i) In case of FSA holders under the above category, whose documents have already been verified against our notice for renewal of FSA & accordingly, FSA has been renewed upto 31.03.2016 are allowed to sign the amendment/addendum after submission of statutory documents like valid Consent to Operate, Factory Licence, Boiler Fitness certificate (in case of CPPs).
- ii) The renewal will not be done in cases where FSA has been terminated/suspended for any reason or where lifting/booking during 2015-16 is less than 30% of effective ACQ, hence liable for termination.
- iii) Where cases are sub-judice in various Court of Laws, such cases will be dealt as per legal advice.
- iv) Signing of amendment/addendum may be allowed to those consumers only after getting clearance from Finance Department, MCL that no outstanding dues pending against them and payment/submission of BG for differential amount towards Security Deposit, if any.
