### NOTICE

AS PER THE SCHEDULED QUANTITY UNDER FSA, ALLOCATION IN RESPECT OF ALL LINKED CONSUMERS (POWER & NON-POWER) ARE SENT TO MCL KOLKATA FOR OBTAINING SANCTION FROM DIRECTOR (RAIL MOVEMENT), RAILWAY BOARD, KOLKATA. IT IS HOWEVER NOTED THAT FOR THE LAST TWO MONTHS OFFICE OF DIRECTOR (RAIL MOVEMENT) UNILATERALLY RESORTING TO CUT ON THE RAKES REQUESTED FOR SANCTION.

IT IS THEREFORE APPREHENDED THAT WITH DISALLOWANCE OF SANCTION BY RAILWAYS FOR FULL ALLOCATION NOT ONLY POWER HOUSES MAY FACE CRISIS OF COAL BUT THE NON-POWER CONSUMERS MAY ALSO GET LESS COAL AGAINST THEIR REQUIREMENT.

IT HAS THEREFORE BEEN DECIDED THAT MCL WILL CONSIDER RELEASE OF COAL EQUIVALENT TO THE CURTAILMENT OF RAKES OF POWER AND NON-POWER CONSUMERS BY RAILWAYS, THROUGH ROAD / ROAD-CUM-RAIL MODE AGAINST THEIR MONTHLY ENTITLEMENT FROM DIFFERENT SOURCES ON COMPLETION OF NECESSARY FORMALITIES AS PER THE EXTANT GUIDELINES.

NOTWITHSTANDING TO ABOVE, CONSUMERS MAY ALSO OPT FOR RELEASE OF PART OF THEIR MONTHLY SCHEDULED QUANTITY BY ROAD MODE AND TO THAT EXTENT REDUCE THEIR OPTION FOR RAIL MODE.
