Dear Sir,

Further to this office letter no. CIL/S&M/47252(New Pol)/792 dated.1/2.12.2014 the decision of 90th CMD's Meet dated 11.11.2014 that the time period for payment of coal value being increased from 7(seven) working days to 10(ten) working days and consequential change in clause 5.2 were informed

But in addition to clause 5.2, clause 6.5 also is to be changed as under:

However, a successful Bidder whose allotted quantity is only 50 tonnes will be allowed to deposit coal value for minimum 90% i.e. 45 tonnes within the stipulated period of 7 days without which the amount shall not be accepted. In such event they shall be permitted to deposit the balance fractional amount, limited to 10 % of the total coal value of 50 tonne, within the subsequent period of 3(three) working days. In spite of this, if they fail to deposit full coal value of 50 tonne (minimum Bid quantity), EMD for entire 50 tonne shall be forfeited.	However, a successful Bidder whose allotted quantity is only 50 tonnes will be allowed to deposit coal value for minimum 90% i.e. 45 tonnes within the stipulated period of 10 days without which the amount shall not be accepted. In such event they shall be permitted to deposit the balance fractional amount, limited to 10 % of the total coal value of 50 tonne, within the subsequent period of 3(three) working days. In spite of this, if they fail to deposit full coal value of 50 tonne (minimum Bid quantity), EMD for entire 50 tonne shall be forfeited.
