NOTICE

Sub: Change of mode of coal supply from Road mode to Rail mode against Linkage Auction Fuel Supply Agreements for willing consumers.

This is to inform to all the coal consumers/buyers that a temporary dispensation is being allowed for all willing road mode consumers lifting coal under Linkage Auction FSA to change mode of supply to Rail mode subject to the following conditions:

- 1. The temporary dispensation shall be allowed for the period of exigency initially for three months i.e. April 2020 to June 2020 and after review with CIL for another three months, if required.
- 2. The dispatch from Rail mode from the linked siding of Primary Source/Secondary Source/any other source as per availability shall be of same or lower grade. No upper grade dispatch will be allowed. However, dispatch from LOCM Group of Sidings, Kanika Siding, Lingaraj 1& 2 Siding, Bharapur Silo and Lingaraj Silo shall be exempt from this dispensation.
- 3. If the Grade of coal of the Primary Source and the grade of coal of the alternate source offered under this dispensation varies then there shall not be any adjustment of grade/quantity for availing supply under this dispensation. An undertaking has to be submitted by the willing consumer to MCL in this regard.
- 4. The modality of calculation of premium for change of mode from Rail to Road shall be applicable while exercising this dispensation for Road to Rail conversion to maintain uniformity of the decision i.e. the highest of the premium fetched in last two concluded tranches of NRS Linkage Auction for all subsectors in the temporary Rail Siding or the % premium originally received in the Primary Road Source from the FSA holder shall be applicable. In case no linkage has been booked from the Rail siding in the latest two concluded tranches of NRS linkage Auction, the %ge premium of Primary Road Source of the FSA holder shall be applicable for supply of coal from temporary source i.e. Rail Siding.
- Consumers willing to avail the facility must submit an undertaking declaring therein that charges related to transporation of coal, Wagon Loading, Under Loading/Over Loading Charges/Demurrage charges and/or any other applicable charges shall be borne by them.

6. Since this is a temporary dispensation, amendment to FSA is not required to be signed. Instead, consumer shall have to submit an undertaking through email towards acceptance of the aforesaid dispensation for change of mode from Road to Rail. Original undertakings shall have to be submitted by the consumers within a week after withdrawal of the restrictions imposed by State authorities due to COVID -19 pandemic outbreak.
