OFFER OF ADDITIONAL COAL ON "AS IS WHERE IS" BASIS FOR POWER GENERATING COMPANIES INCLUDING IPPS DRAWING COAL UNDER FSA

This is further to our earlier notice no.MCL/SBP/GM(S&M)/COMML/AS-IS-WHERE-IS/2013/284, dtd.30.04.2013 regarding offer of coal to all power generating companies including IPPs drawing coal under FSA during 2013-14 by making their own arrangement for evacuation on 'as is where is' basis, CIL vide letter no.CIL/S&M/As is where is/120, dtd.24.03.2014, has conveyed the approval of continuance of "as is where is basis scheme" for the year 2014-15 on the same terms and conditions for offer of coal under the scheme, which had been in vogue in 2013-14 with an directive that "it shall be reiterated that such coal which is not present at the railhead alone shall be offered under the scheme".

In view of the above, the following collieries are put under the above scheme for 2014-15 as one time offer with the stipulation that power generating companies including IPPs drawing coal under FSA will have to make their own arrangement for evacuation.
