Subject: Diversion of 35.152 ha. of forest land for renewal of lease  
of Duela bada Colliery of SECL in Dhenkanal district of Orissa.

Sir,

I am directed to refer to your letter No.10P(Cons)78/50/14864/PEAH dated 19.6.98 and No.10P(C-ons)33/95/4635/P&E dated 4.3.1995 on the above mentioned subject seeking prior approval of the Central Government in accordance with Section-2 of the Forest (Conservation) Act, 1980 and to say that the proposal has been examined by the Advisory Committee constituted by the Central Government under Section-3 of the aforesaid Act.

2. After careful consideration of the proposal of the State Govt., and on the basis of the recommendation of the above mentioned Advisory Committee, the Central Government hereby conveys its approval under Section-2 of the Forest (Conservation) Act, 1980 for diversion of 35.152 ha. of forest land for renewal of lease of Duela bada Colliery of SECL in Dhenkanal district subject to the following conditions:-

- i) Legal status of the forest land will remain unchanged.
- ii) Compensatory afforestation to be raised over double the degraded forest land.
- iii) Implementation of Reclamation Plan at the cost of User Agency.
- iv) The forest land should not be used for any purpose other than specified in the proposal.
