Clause-10.3.11.6 of CIL's Purchase Manual is hereby amended to the following effect:

Old Clause

The release of the Performance Bank guarantee(s) after above indicated period, shall be subject to satisfactory performance of the equipment/ items during the warranty period and fulfillment of contractual obligations failing which, action for further extension or encashment of PBG, as deemed suitable shall be taken. The Performance Bank Guarantee shall be released after expiry of validity period if No Claim Certificate is received from the concerned HOD (MM)/ Area GM and the contractor indicating that there is no claim pending and that there is no dispute pending, respectively. However, in case there is no dispute pending & No Claim Certificate is not received in writing from the user within 6(six) months from the expiry of the validity period, the BG shall be released without further reference to the user, with the approval of the Director (T) of the concerned subsidiary/CIL.

Amended Clause

The release of the Performance Bank guarantee(s) after above indicated period, shall be subject to satisfactory performance of the equipment/ items during the warranty period and fulfilment of contractual obligations failing which, action for further extension or encashment of PBG, as deemed suitable shall be taken. The Performance Bank Guarantee shall be released with the approval of concerned HOD (MM) / Area GM after expiry of validity period after obtaining the following:

- 1. 'No Claim Certificate' from concerned HOD (User Dept.) indicating that there is no claim pending.
- 2. 'No Claim Certificate' from the contractor indicating that there is no claim pending and there is no dispute.

However, in case there is no dispute pending and contractor has issued 'No Claim Certificate' but 'No Claim Certificate' is not received in writing from the user within 6(six) months from the expiry of the validity period, the BG shall be released without further reference to the user, with the approval of the Director (T) of the concerned Subsidiary/CIL.
