

Vigilance Awareness Week Short Film Competition -2022

Central Vigilance Commission (CVC), as part of its continuous effort to involve public as active participants in ensuring a "Corruption Free India", observes Vigilance Awareness Week every year. This year CVC has directed vigilance units of all Departments of the Government and Public Sector Undertaking to observe Vigilance Awareness Week-2022 from 31.10.2022 to 06.11.2022.

As a part of Vigilance Awareness Week - 2022 conducted by MCL, Vigilance department, Short Films are invited for the 'Short Films Competition' on the following theme.

**“भ्रष्टाचार मुक्त भारत - विकसित भारत”
"Corruption free India for a developed Nation".**

Rules:

- ❖ Any employee or group of employees of Mahanadi Coalfields Limited can participate with/without family members.
- ❖ The Short Films shall be in Hindi or English or Odia language. In respect of Short Films other than in English, Subtitles in English are required.
- ❖ The length of the Short Film should not be less than 03 minutes and more than 10 minutes. End credits at the end of Short Film are limited to 60 seconds only. The End Credits must mention: "This film was made for MCL, Vigilance department during the Vigilance Awareness Week - 2022". Opening titles and End credits are considered to be part of the film, and shall be counted in total duration of Film.
- ❖ Short films should have been taken after 25th September 2022 only. Short Films shall be Original.
- ❖ The last date of submission of short film is **25TH OCTOBER 2022** and Short Films received after 25.10.2022 will not be accepted.
- ❖ The applicant should have Gmail account with Google drive access. The Short Film should be uploaded in the folder of Google drive with title "VAW Short Film Competition-2022, <name of applicant>" and the General access to the folder link should be given to the department (inquiryvig.mcl@gmail.com) as Editor. The link of the folder of Google drive should be forwarded through Email on:- **inquiryvig.mcl@gmail.com** (No hard copy of application or DVD/Pen drive is required). The applicant must write his/her complete details such as Name of Leading Employee, Designation, Employee No., Place of Posting, and mobile number in the Email.
- ❖ All costs incurred for making of the short film shall be incurred by the contestants. MCL - VIGILANCE DEPARTMENT will not bear any expenses regarding the same.
- ❖ The decision of the jury constituted by MCL, Vigilance Department in selection of the winners shall be final. No correspondence in this regard is allowed.
- ❖ The selected Short films will be screened during the Vigilance Awareness Week.
- ❖ These films also will be screened at other events of MCL for the purpose of raising awareness among workers / employees and the public at no cost to the film owner.
- ❖ The films will also be used for awareness creation including through Social Media. If required, the selected short films will be uploaded in YouTube channel with or without editing by MCL.
