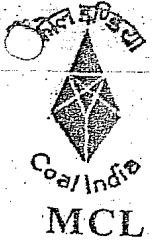

It is observed that regarding definition of similar work, different areas are mentioning different definition of works even for same type of jobs which leads to ambiguity.

Hence in order to maintain uniformity in tenders from different areas and MCL HQ, a broad guideline is hereby circulated detailed as under-

DEFINITION OF SIMILAR WORK IN NIT FOR AREAS & MCL HQ.		
Category	Tendered Work	Definition of Similar work to be mentioned in NIT.
A	ANY TYPE OF ROAD WORK	ROAD WORK
B.	BUILDING WORKS(Service, Residential & Non-Residential Building)	BUILDING WORK
C	External Water Supply OR Sewerage works	External Water Supply OR Sewerage works
D.	Boundary wall, Drain, Retaining Wall, Toe Wall, Pump Foundation/Shed and other Masonary OR Concrete works	Any Civil Engineering Work containing Masonary AND / OR Concrete works.
E	Upkeeping and maintenance of residential/non-residential premises/ lawn / garden, Water supply through tankers, water sprinkling on roads, cutting of kutchra drain/garland drain, petty civil works etc.	Any Civil Engineering Work


