महोदय,

The tender for setting-up of Basundhara Washery (10 Mty) on "Build-Operate-Maintain" (BOM) concept was invited in May' 2013 vide Bid Notice No. MCL/SAMB/Washery/13-14/01 dated 20.05.2013. M/s ACB (India) Ltd. (M/s ACB(I)L) has participated in the above said tender in "Sole Bidder Route" for "Setting-up of Basundhara Washery (10 Mty) on BOM concept" near Kulda OCP, Basundhara Area, MCL and submitted a Bank Guarantee (BG No. 16090100001059) of Rs. 50.00 Lakhs as Bid Security as per the provision of Bid Document. The tender was finalized and "Letter of Intimation (Lol)" was issued to M/s ACB (India) Ltd, vide our Lol mentioned at reference at (iii) MCL/HQ/GM(Washery)/ RFP-Bas/14-15/197 dated 27.05.2014.

Further, as per the provisions of Bid Document, M/s ACB (India) Ltd. was requested to extend the Bid Validity and validity of Bid Security vide our letter's no. 2290 dated 01.10.2019, 2352 dated 22.10.2019, 2386 dated 08.11.2019, 2446 dated 02.12.2019, 2473 dated 07.12.2019, 2521 dated 27.12.2019, 2548 dated 06.01.2020, 2552 dated 08.01.2020 and 2577 dated 14.01.2020 to keep the Bid alive without any modification in other terms and conditions of its Bid. M/s ACB (India) Ltd. vide letter no 05 dated 16.01.2020 agreed to MCL's request and extended the validity of Bid by 03 months i.e. 18.04.2020 and validity of Bid Security upto 18.04.2020 with claim period upto 18.05.2020 with a condition to re-working of compensation formula particularly keeping in mind the prices discovered during recent tenders floated by MCL in 2018. However, MCL vide letter no. 2655 dated 20.02.2020 further requested M/s ACB(I)L to submit the extension of Validity of Bid upto 18.10.2020 and validity of Bid Security upto 18.11.2020 without any modification in other terms and conditions of its Bid.

In response to the MCL's letter no. 2655 dated 20.02.2020, M/s ACB (India) Ltd. has expressed that M/s ACB(I)L is not in the position to extend the validity of Bid and Bid Security and requested MCL to accept their inability to extend the Bid Validity and return the Bank Guarantee considering the provisions of Cl. No. 2.3.1 (ITB – Page-6) of Bid Document.

Since, M/s ACB (India) Ltd. has not extended the validity of Bid & Bid Security without any modification in other terms and conditions of its Bid as per the request of MCL, the Letter of Intimation (LoI) issued to M/s ACB (India) Ltd. vide no **MCL/HQ/GM(Washery)/ RFP-Bas/14-15/197 dated 27.05.2014 is hereby cancelled**. Further, in view of the cancellation of tender and Letter of Intimation issued against Bid Notice No. MCL/SAMB/Washery/13-14/01 dated 20.05.2013 for setting-up of Basundhara Washery (10 Mty) on "Build-Operate-Maintain" (BOM) concept, the Bid Security of Rs. 50.00 Lakhs furnished alongwith the bid in the form of BG (BG No. 16090100001059), Bank Name – Axis Bank Limited is being hereby returned to M/s ACB (India) Ltd.
