Vide above reference, QCI under intimation to all Subsidiaries was informed by CIL that the extension of QCI empanelment was up to 25.05.2023 or issuance of LoI / Work Order against new tender by CIL, whichever is earlier.

The Tendering process by PFC and CIL are presently under process and unlikely to fructify by 25.05.2023.

In view of above, it has been decided that the consumers having existing tripartite agreements (TPAs) signed with QCI may be allowed to extend the same for a period up to 03 months (i.e. up to 25.08.23) with the existing terms & conditions of the Tripartite Agreement to take care of the sampling continuity.

This will be subject to further following stipulations:

- a. QCI would be allowed to participate in the tender(s) as per terms and conditions of the incoming open tender of CIL and /or PFC, as and when these are floated.
- b. In the meantime, if the process of empanelment by PFC or by CIL is completed, then the present extension shall be reviewed.

Coal Companies may also notify the above extension of Tripartite Agreements (TPAs) with QCI to the respective consumers.
