

Minutes of Meeting held on dtd.10.02.2015 at MCL HQ, with the Representatives of Power House's regarding Deployment of 3rd Party Agency on their behalf for Samplin/Analysis works at the loading points of MCL

At the outset GM(QC), MCL welcomed all the representatives of different Power Houses present in the meeting. The meeting was to be chaired by DT(OP), MCL, but due to urgent meeting at Talcher Coalfields, he could not attend.

First of all GM(QC) & GM(S&M), MCL appraised all the PH's representatives about the main agenda of the meeting i.e. deployment of 3rd Party Agency by PHs at loading points of MCL. The representatives of respective PHs have informed the present status on deployment of 3rd Party Agency which are stated below;

- 1) M/s. WBPDCCL : Mr. Anup Kumar Biswas, Manager(FM) had attended the meeting on behalf of WBPDCCL PHs. During interaction he informed that, they are in the final stage of Tendering towards deployment of 3rd Party Agency & accordingly Pre-bid Meeting has been fixed on 12.02.2015. About 2 months is required to award the work against the Agency who will be selected. After selection of 3rd Party Agency the modalities of sampling/analysis shall be prepared mutually before deployment of the Agency.
- 2) M/s. NTPC-Mouda : Sri N.K. Thakur, AGM (Chemistry) had attended the meeting on behalf of NTPC-Mouda PH. He informed that they have already finalized their 3rd Party Agency i.e. M/s. Cotecna Inspection India Pvt. Ltd. & the work will start from 16.02.2015. During interaction he wanted to know the modalities to be implemented for Sampling/Analysis. GM(QC) informed that prior to deploy the Agency the modalities shall be prepared on mutual understanding of both in line with the guidelines SOP/FSA circulated by CIL.
- 3) M/s. TANGEDCO: Sri. Justin Jagdeep Kumar, Exe. Engineer (Mech/Coal) had attended the meeting on behalf of TANGEDCO PHs. He has expressed that continuation of the existing system of 3rd Party sampler engaged by CIL, in the presence of MCL & TANGEDCO representatives is acceptable to TANGEDCO. He also informed that regarding deployment of 3rd Party Agency at loading points of MCL, the matter will be finalized by their higher authorities & the final decision shall be communicated in due course to MCL.
- 4) M/s. APGENCO: Md. Ishak (Asst. Engineer) had attended the meeting on behalf of APGENCO PHs. He informed that regarding deployment of 3rd Party Agency at loading points of MCL, they will inform their higher authority towards deployment of 3rd Party Agency & the final decision shall be communicated to MCL.
- 5) M/s. Durgapur Project Ltd: Sri. Subroto Ray , Manager(Fuel) & Sri. Abhishek Saha, Asst. Manager (F&A) had attended the meeting on behalf of DPL PH. They have also expressed their satisfaction in the existing system of Sampling/Analysis of coal being implemented at the loading points of MCL by the 3rd Party agency deployed by CIL, Kolkata. They have informed that they have already finalized & awarded to M/s. K.C. Sharma & Co. for the deployment at loading points of MCL.

GM(S&M), MCL informed that, the amendment which has been made in the existing FSA regarding "Sampling" should be signed by all authorized FSA signatories of Power Houses/Power Utilities. Accordingly he had requested all the representatives to convey the same to their respective higher authorities for its compliance. In addition to this, he also requested to send the matrix of ash percentage to Sales & Marketing deptt. of MCL, since they are using varieties of coal from different sources.

The meeting ended with vote of thanks to the chair.
