
Dear Sir,

In continuation to our Notice Ref. No. CIL/C-4B/TPA/2022/22 dated 11.03.2022 (copy attached as **Annexure-1**), all the Coal Companies are hereby informed that:

1. The validity of the empanelment period of M/s SGS India Pvt. Ltd (CIL empaneled Third Party Sampling Agency) shall be expired w.e.f. 15.03.2024 (00:00 Hrs).
2. All the consumers with whom individual Tripartite Agreement with M/s SGS India Pvt. Ltd are in vogue shall be informed that the willing consumer(s) can engage any other empanelled agency of their choice considering the expiry of contract.
3. Coal Company / CIL shall not be liable for any consequences in the event of discontinuation of sampling. And in the absence of Third-Party sampling, quality settlement will be as per the provisions of FSA.
4. All the samples collected by M/s SGS India Pvt. Ltd till 14.03.24 shall be analysed and reported as per the timelines and provisions of Tripartite Agreement / RFP.
5. All the pending referee samples lying at different areas of the Coal Companies shall be sent to designated referee labs in line with provisions of RFP/ TPA.
6. Results of all the pending referee samples shall be reported as per the timeline of the RFP/ TPA.
7. Coal Companies are requested to extend all the support as mentioned in RFP / TPA to M/s SGS India Pvt. Ltd even after expiry of the contract for preparation of the samples collected till 14.03.24, sending referee samples to designated referee labs, etc.
8. All the Coal Companies are requested to peruse the terms and conditions of the RFP/ Tripartite Agreement and take action as deemed necessary if any.
9. All Coal Companies shall notify the above to all the concerned.

**Subject: Extension of empanelment period of the empaneled Third Party Sampling Agencies M/S COTECNA Inspection India Private Limited and SGS India Private Limited**

Notification for letter of empanelment have been issued by CIL on 15.03.2021 to M/S COTECNA Inspection India Private Limited and SGS India Private Limited for undertaking the job of sampling and analysis of coal samples at loading end in CIL subsidiaries.

The Tripartite Agreement was issued on 05.04.2021 in public domain.(Copy of the agreement is enclosed herewith )

Presently, many consumers have signed agreement with M/S COTECNA Inspection India Private Limited & M/S SGS India Private Limited for third party sampling & analysis at CIL Subsidiaries during 2021-22 and the job is being continued.

The Clause S.4.2. of the Tripartite Agreement is appended below:

**“ The maximum tenure of empanelment shall be 03 years. Towards this, initial contract shall be for a period of 01 (one) year and on successful completion of the same, it may be extended for a period of 02(two) years on mutually agreed terms by the parties.”**

The empanelment of these two Third Party Sampling Agencies will due to expire on 15.03.2022, after completion of one year.

As per the extant clause S.4.2. of the Tripartite Agreement, it is proposed for extension of empanelment of the empanelled Third Party Agencies viz., M/S COTECNA Inspection India Private Limited & M/S SGS India Private Limited for a period of 02(two) years from 15.03.2022, i.e. upto 14.03.2024 on the same terms & conditions. Tripartite Agreement(s) may be executed/extended, as the case may be, on consensus amongst all the three parties (CIL Subsidiary, respective Consumer(s) and the Third party Sampling Agency).

Competent Authority may kindly approve the extension period of empanelment of these Third Party Agencies. On approval, this will be intimated to the CIL Subsidiaries and the empaneled Third Party Sampling Agencies, M/S COTECNA Inspection India Private Limited & M/S SGS India Private Limited, for information and needful.
