Kindly refer to this office letter of even no 40 dated 16th February 2016, whereby it was inter-alia communicated that

"....Accordingly, existing third party agencies of either sides shall have the liberty of communicating the results of analysis within 18 (eighteen) working days from the date of sample collection to coal cos. and the power plants where after coal cos./ power plants may raise disputes, if any or if at all; within 07 (seven) days of the submission of results by the Third Party. This direction shall be deemed to have come into effect with effect from the date of issue of guidelines i.e. on and from 26.11.2015."

in regard thereto, coal companies have represented regarding change in the date from when guidelines would come into effect i.e. instead of the day when guidelines were issued 26.11.2016 to the day when the guidelines have been communicated i.e. 16th February 2016. The rationale contended is that the referee samples for the intervening period were preserved only as per earlier SOP whereafter samples were destroyed and thus there is no referee sample.

The request of the coal companies were examined at CIL and it is accordingly conveyed that aforesaid direction shall be deemed to have come into effect on and from 16th February 2016.
